**Player Intent to Play with Lake Norman Soccer Club (LNSC)**

\_\_\_\_\_ The LNSC Code of Conduct has been read and we agree to comply (parents and player) with these expectations and be subject to discipline for violations determined by LNSC. A copy of the LNSC Code of Conduct is located on the website under Forms. The LNSC Parent & Player Handbook has been provided and read.

\_\_\_\_\_ One of LNSC's main objectives is player development; therefore, we reserve the right to make coach, team, and/or level of play modifications as deemed appropriate throughout the year by club directors.

\_\_\_\_\_ I understand that this commitment to LNSC extends through May 31, 2019.

**Financial Contract**

\_\_\_\_\_ **Club Fees** (of \$ \_\_\_\_\_ for 2018-2019) are paid directly to LNSC to cover expenses such as, but not limited to, training fees, field rental, player registration, and office administration. These fees are set by LNSC based on the various levels of play offered at LNSC. The fee structures and fee schedules are posted on the LNSC website. All LNSC players must purchase a uniform kit from soccer.com which run on two-year cycles. Players are also responsible for having proper training attire at all training sessions, which may be purchased as needed from soccer.com. Prices and details for the required uniform items are available within the LNSC soccer.com team store.

\_\_\_\_\_ **Team Fees** are separate expenses paid directly to my assigned team. Team fees cover expenses such as tournaments, referee fees, coach's travel, etc. These fees will vary from team to team and are based on the number of tournaments and travel my team participates in (team budget). The U9/U10 Academy will also pay Team Fees; however, they will be paid directly to LNSC. Elite program Team Fees are included in Club Fees. All expenses to travel with the team to and from practices, scrimmages, games and tournaments are my responsibility. This includes gas, food, room and board, etc. Dual rostered players will be responsible for a prorated portion of their non-primary Team Fees.

\_\_\_\_\_ By signing this contract, I acknowledge that I have read and understand this form in its entirety and understand my family's financial obligations to LNSC. I also acknowledge and agree to the following terms and conditions:

- The commitment fee is non-refundable. Upon commitment to a team, I am entering into a legally binding financial contract with LNSC. I am financially responsible for all Club Fees as stated for the entire playing year.
- Upon commitment to LNSC, players will not be released to re-roster to another NCYSA affiliate organization unless all Club Fees and Team Fees are paid in full. Requests for releases and withdrawals must be presented in writing to Chad Metzler at [cmetzler@lakenormansoccer.com](mailto:cmetzler@lakenormansoccer.com).
- Players with a season ending injury incurred while participating in an LNSC event may be eligible for a prorated refund or credit with the amount to be determined on a case-by-case basis.
- Players moving more than 100 miles during the season are eligible for a prorated refund with the amount to be determined on a case-by-case basis.
- All fees must be paid on time according to the published payment schedule. Statements will not be mailed. Any Club Fee or Team Pay payments that are delinquent may be cause to suspend a player from practice or playing in games. I agree that if I am more than ten days late with payment in accordance with the approved fee structure, I will be subject to a \$25 late fee. I also agree that non-payment of amounts owed will subject me to legal collection proceedings and that I will be responsible for any related costs.
- Returned checks are subject to a \$30 fee. Following a returned check, payments must be made with cash or credit card.
